

NOTICE CUM ADDENDUM

This notice cum addendum of the Combined Scheme Information Document (“SID”) and Combined Key Information Memorandum (“KIM”) of the open ended equity schemes of Baroda Pioneer Mutual Fund (“Mutual Fund”) is being issued to inform investors/unit holders of the changes that are being effected in the SID and KIM, effective November 1, 2015 :
